*Note: For the arid southwestern cotton belt (west of I-35), use the following crop rotation intervals if the cotton crop is grown to maturity (i.e., irrigation maintained and/or the crop not lost to drought) and the fields have had thorough soil mixing (for example, two diskings or a deep plowing) prior to planting the rotational crop. If the above conditions are not met, a field bioassay should be completed prior to planting any desired crop.
